**Regional Manager Report:** 1) The Regional Manager reported on presentations she participated in during the month of January. 2) The Functional Screen process has now been updated with feedback from the Office of Resource Center Development (ORCD) to guide staff on eligibility issues. 3) Terese Poe and Janet Weber have been identified as contacts for ORCD relating to a systematic review of current business needs and future IT development. They will provide feedback regarding the use of current reporting systems.

**Family Care Updates:** The recently submitted Governor's budget mandates that all counties must be in a Managed Care Organization for Family Care by January 1, 2017. The Vilas County Ad Hoc Family Care Committee will be extending an invitation to all counties and tribes in the Aging & Disability Resource Center of the Northwoods to meet with State of Wisconsin representatives to determine how best to proceed from here. A regional ad hoc planning committee similar to the one used to develop the ADRC-NW may be set up at some future point.

**Dashboard Report:** Comparisons were reviewed for 2013 and 2014 calls, follow up calls, and functional screens. January 2015 figures were then compared to those of January 2014. For the call totals, only actual customer calls will be counted in the future. Parkkila reported that the Disability Benefit Specialist (DBS) caseloads are now at the state average, rather than close to double as they were before the part-time DBS was hired in Medford.

**Future Agenda items:** Discussion on how time reporting is done; discussion on keeping our marketing program fresh; discussion on developing a plan for staff development, keeping staff morale high, and retaining staff
